



# 100% Totally/Permanently to include TDIU

## Disabled Benefits

December 2021

If you are receiving benefits from the Department of Veterans Affairs (VA) and have a service-connected rating of 100% Permanent & Total (P&T) or Individual Unemployability Permanent & Total (P&T), you may be eligible for the following.

- **Commissary Benefits** – Present VA letter of award, statement for dependency (marriage lic., birth cert.), and DD214 to I.D. office at military installation for photo I.D. good for admittance to military installation for commissary/MWR use only.

- **Dependents Healthcare** – Benefits exclusively for the dependents from CHAMPVA when presented Form 10-10D, and 10-7959C.

- **Life Insurance Premium Paid** – Only if award is for a “new” disability award, and comes before the 65<sup>th</sup> birthday of the veteran, and the veteran is NOT employed.

- **Dependents Education** – Dependent Education Assistance Chapter 35 for the dependents of the veterans including your spouse (up to 12 years after award), children (18-26).
- **Property Tax Exemption** – Equal to taxes up to \$50,000 of the market value of an eligible taxpayer’s homestead (Ohio Form DTE 1051). Contact your county Auditor’s Office
- **License Plates** – Ohio BMV will provide Disabled plates with disabled veteran printed on them (Form BMV 4507)
- **Driver’s License** – The driver’s license is only provided to the veterans who have the disabled plates.
- **Camping at Ohio Parks** – Must have disabled veteran plates, Photo I.D., or possibly even VA letter.
- **Hunting/Fishing License** – Department of Natural Resources Form DNR9032-B (R0713).
- **Student Loan Forgiveness** – Through the U.S. Department of Education apply with form OMB No. 1845-0065.
- **VA Dental Care Benefits** – You’re in: Class IV, you may qualify for: Any needed dental care.
